# Supporting Community Life Engagement for People with Intellectual and Developmental Disabilities

This session will focus on how day services and supports for people with intellectual and developmental disabilities can support community life engagement (CLE). CLE includes all the ways that people with and without disabilities access and participate in their communities outside of employment. Activities can include volunteer work; postsecondary, adult, or continuing education; accessing community facilities such as the library, gym, or recreation center; and any other activities that people with and without disabilities do in their spare time. Research on supports for CLE, tools for service providers, and new opportunities to learn more and engage in a community of practice on CLE will be presented.

#### Jennifer Sulewski, PhD

*Jennifer Sulewski* is Associate Director and Assistant Research Professor at the Institute on Disability, University of New Hampshire. She is a national expert on community life engagement (CLE) for people with intellectual and developmental disabilities. She has authored numerous publications on CLE, presented locally and nationally at conferences, and provided consultation to state agencies and service providers across the country on how to improve day services and supports. She is currently Principal Investigator of a NIDILRR-funded knowledge translation project to establish a national Community of Practice on CLE.

*Lindsay Shea* is the Director of the Policy and Analytics Center at the A.J. Drexel Autism Institute, and an Associate Professor. The mission of the Policy and Analytics Center is to utilize innovative analytic strategies to support the development of effective social and health policy in cities, states, and across the US. Dr. Shea leads autism-focused projects at the local, state, federal, and international levels. Dr. Shea first-authored the Pennsylvania Autism Census Report and her research interests are creating and using an evidence base in forming, evaluating, and implementing social and health policies. Dr. Shea holds a doctoral degree in health policy from the Drexel University Dornsife School of Public Health, Department of Health Management and Policy, and a master's degree in social policy from the University of Pennsylvania School of Social Policy and Practice.

This session will provide a view of trauma from the perspective of the lives of people with intellectual disabilities. It will explore the sources of trauma and the common effects of that trauma on both a biological and psychological level. The key ingredients for healing will be explored and case studies will be shared.

*Karyn Harvey* has worked as a clinician in the field of intellectual disabilities for over 35 years. She has her PhD in Applied Developmental Psychology from the University of Maryland. She has written three books: Positive Identity Development, Trauma-Informed Behavioral Interventions, and Trauma and Healing. She has a private practice and does therapy with people with intellectual disabilities. In addition, she regularly conducts trainings on trauma-informed support for people with IDD, trauma-informed leadership, and trauma-informed behavioral interventions for both state and individual organizations throughout the US and Canada. She also conducts a train the trainer program and has trained over 120 trainers throughout the US and Canada. Finally, she has received several national awards for clinical excellence in the field of intellectual and developmental disabilities: NADD 2016, AAIDD, 2020, and START 2023.

**Sara Murphy** is a Senior Training Associate for TransCen, Inc. For more than 30 years, Ms. Murphy's focus has been on community inclusion and employment for transition-age youth and people with disabilities. She has extensive experience in program development and management, community-based services, customized employment, and employer engagement. As part of TransCen's technical assistance and training team, she is now working with federal/state agencies, school districts, service providers, employers, and individuals/families across the country to improve community inclusion and employment outcomes for people with disabilities. Currently, her projects include several federal and state initiatives regarding system change/service transformation, transition, and employment. She is a Subject Matter Expert for the Department of Labor's Office of Disability and Employment Policy (ODEP) and supports the office's efforts around interagency collaboration and employment services.



The Boggs Center's Developmental Disabilities Lecture Series is a community and continuing education program provided for professionals, policymakers, individuals with disabilities, and family members to enhance their knowledge and skills in innovative approaches and state of the art practices for people with developmental disabilities. Nationally known speakers with expertise in their field serve as faculty for the program.
