Diversity, Equity, & Inclusion and Person-Centered Practice

The population of those who experience developmental disabilities is diverse. Cultural and racial identities shape views and expectations of service systems, impacting which supports, if any, people with disabilities and their families choose and use. This presentation will center on the importance of understanding a person's racial and cultural identities for providing person-centered supports with cultural competence and humility. Key concepts related to diversity, equity, and inclusion will be explored and personal narratives of people with disabilities will be shared to demonstrate the alignment of cultural competence and person-centered planning and practice.

Supported Decision Making

Supported decision making is gaining momentum as a means to support people with disabilities through making life choices while promoting independence, dignity, and freedom. The practice of supported decision making as an alternative to guardianship will be introduced through this presentation. It will also describe the importance of approaches embedded in supported decision making, why they are important, and the benefits they can have for the persons being supported. Resources to learn more about supported decision making and tools to support implementation will be shared.

Kendrick, PhD is Director of Supported Decision Making at the Center for Public Representation and an independent international consultant in human services as it relates to aging, disability and mental health. He has had ongoing involvements in the United States, Canada, Australia, New Zealand, the Netherlands, Ireland, the UK, and other countries. His interests, involvements, and writings have included leadership, service quality, the creation of safeguards for vulnerable persons, intentional personal networks, social integration, change, innovation, values, advocacy, the role of individual persons and small groups in creating advances, evaluation, alternatives to bureaucracy, supported decision making, personalized approaches to supporting people with complex needs, and reform in the human service field amongst others. He has independently evaluated many hundreds of programs, agencies, and systems over the past four decades and spoken to tens of thousands of people.

Acknowledging and Fostering the Critical Role of Support Coordinators

Support Coordinators serve a critical role in the lives of people with disabilities and their families, as well as in formal service systems. Their varied and multi-faceted role requires core knowledge and skills to ensure consistent, high quality, person-centered supports. Despite the need for highly competent professionals, support coordination is one of the few positions without a standardized set of core competencies. This presentation will highlight both national and state specific efforts to develop, adopt, and implement core competencies, including the common elements between the various examples, and how these elements can be customized to fit the context of support coordination in New Jersey.

She also served on state wide work groups for implementation of the Home and Community Based Settings rule throughout the state of Missouri, the development of the Missouri Support Coordinator Core Competencies and related tools, and the revision of directives, guidelines, and service definitions. Her passion for the development and implementation of best practice that will drive systems change and impact families originates in growing up as a sibling of a sister with a developmental disability.
